Eligibility

Alliance members, their children and grandchildren are eligible. Each applicant must be a high school senior planning to be a full-time college student, or a full-time college student during the 2018/2019 school year. To ensure fairness in the judging, Alliance employees, officials and their immediate family members are not eligible, nor are past Alliance scholarship recipients.

Scholarships to be Awarded

Alliance will award five \$1,000 scholarships. Scholarship funds will be paid to the university in the student's name.

Selection and Presentation

Judging will be completed by a panel consisting of employees and will be based solely on a review of the application information. There is no grade point average or college test score to qualify. Winners will be notified in early March and will be honored at the Annual Membership Meeting on Wednesday, March 28, 2018.

How to Apply

1. Complete the Application

2. Write an essay: If you had the authority to change your community in a positive way, what specific changes would you make and what steps would you take to make them?

The essay should be typed and double-spaced. Selected essays may be used by Alliance Credit Union for internal or external publication.

3. Write why you need the scholarship: Describe any personal or family circumstances affecting your need for financial assistance. If you do not need financial assistance, please tell us why you are a good candidate.
